

NC Beer Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. The NC Beer Sweepstakes (“Sweepstakes”) begins at 12:00:00 AM Eastern Standard Time on or about March 30, 2019 and ends at 11:59:59 PM Eastern Time on April 30, 2019 (“Sweepstakes Period”). Administrator’s computer is the official time-keeping device for the sweepstakes.

ELIGIBILITY: The Sweepstakes is open only to legal residents living in the United States and Canada who are at least 21 years of age. Employees, officers and directors of the Economic Development Partnership of North Carolina or the NC Craft Brewers Guild (“Sponsors”), or Luquire George Andrews (“Administrator”) or any of the participating Sweepstakes partners, their affiliates, subsidiaries, advertising, promotion, fulfillment and marketing agencies (collectively, with Untappd and Jebbit, Inc., “Released Parties”), their immediate families (spouse, and parents, children, siblings and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate in the Sweepstakes. By entering the Sweepstakes, participants agree to these Official Rules and agree to release, discharge and hold harmless Released Parties, from and against any claim or cause of action, including, but not limited to, any damages, personal injury or death, which may arise out of participation in the Sweepstakes or out of the acceptance, use, misuse or possession of any prize (including any travel or activity related thereto). By participating, you agree to the decisions of the Sponsor and/or Administrator, which are final and binding in all aspects. Void where prohibited by law, rule or regulation. All applicable Federal, State and local laws and regulations apply.

HOW TO ENTER: Entries are limited to up to five per person/email account for the entire Sweepstakes Period. Any entries over five from any person or email account and entries in excess of the stated limitation will be void. To enter, complete at least one of the following entry points:

- To enter on NCBeerMonth.com, you must complete the entry form with your first and last name, complete address, city, state, ZIP code and your email address. After entering correct information in all the fields online and clicking on the Submit button, you will immediately receive one entry into a database for a random drawing to win one of the three Sweepstakes packages. Handwritten entries will be manually entered into the database before the drawing is held. Entries via NCBeerMonth.com are limited to one per person/email account for the entire Sweepstakes Period.
- To enter using the Untappd app, you must download the Untappd app on your phone and unlock the NC Beer Month badges by checking-in to at least five North Carolina breweries **and tagging the location where you are enjoying a beer**. Checking-in to five total North Carolina breweries unlocks NC Beer Passport Badge Tier 1 and earns you one entry into the Sweepstakes. Checking in to **ten** total North Carolina breweries unlocks NC Beer Passport Badge Tier 2 and earns you one additional entry into the Sweepstakes. Checking in to **fifteen** total North Carolina breweries unlocks NC Beer Passport Badge Tier 3 and earns you another entry to the Sweepstakes. Entries via Untappd are limited to three per person/email account for the entire Sweepstakes Period. **You can only check in to each location once**. No purchase is necessary to receive these entries – Untappd users are not required to purchase a beer to check in a brewery.

Entries will be deemed made by authorized account holder of the email address submitted at time of entry. The authorized account holder is deemed as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email

address. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the sole property of Sponsor. By submitting an entry, entrant represents and warrants that the entry conforms to these Official Rules and understands that Sponsor, in its sole discretion, may disqualify the entry for any reason, including if it determines, in its sole discretion, that the entry fails to conform to these Official Rules in any way or otherwise contains unacceptable content as determined by Sponsor, in its sole discretion.

WINNER DETERMINATION AND NOTIFICATION: The potential Sweepstakes winners will be selected on or about May 7, 2018 in a random drawing from all eligible entries received. Odds of winning any prize depend on the number of eligible entries received. In no event will Sponsor award more than the number of prizes stated herein. Potential winners will be notified via email. Potential winners must respond to the initial notification within 48 hours of the initial contact. The potential Grand Prize winner must sign, notarize and return an Affidavit of Eligibility and Release of Liability document within 10 days of receipt, prior to issuance of prize vouchers. Potential winner may be required to show proof of being the authorized account holder. Non-compliance or, if a selected potential winner cannot be contacted, is ineligible, fails to claim prize, fails to respond to the initial notification within the stated time period or fails to return all required documents within the stated time period, or if a prize notification or prize is returned as undeliverable, an alternate winner may be selected.
